



- 1. In reference to **DepEd Memorandum No. 063, s. 2024** dated November 15, 2024, Re: **2024 Accreditation and Equivalency Test Registration and Administration Guidelines**, the field is hereby informed of the administration of the Accreditation and Equivalency (A&E) Test on February 02, 2025, 6:30 in the morning at Dapa Central Elementary School and SPED Center and Bureau of Jail Management and Penology Siargao.
- 2. Only the registered applicants with complete requirements shall be allowed to take the A&E Test at the testing centers approved by BEA. No walk-in A&E Test takers shall be accommodated.
- 3. Attention is directed to the following enclosures, for the information, reference and guidance of qualified A&E takers and testing personnel involved in the test administration, to wit:
  - i. Enclosure 1: List of Examinees and Room Assignment
  - ii. Enclosure 2: A&E Testing Personnel
  - iii. Enclosure 3: Monitoring and Evaluation of the A&E Test
- 4. To ensure smooth and standardized test administration, all testing personnel shall attend the orientation of the aforementioned assessment on January 30, 2025, 1:30 PM at the Division Office Training Center.
- 5. All expenses incurred for the A & E orientation, monitoring and administration including test materials (such as but not limited to pencil, paper, paste, and bond paper), transportation, meals and honorarium of the testing personnel shall be charged to NASBE Program Support Funds subject to the usual accounting and auditing rules and regulations.
- 6. Service Credits or Compensatory Time-Off (CTO) shall be granted to the participants if the activity falls on holiday, weekend, cancellation or suspension of classes and work in the Government Office due to typhoon, flooding, other weather disturbances, and calamities pursuant to guidelines specified in DepEd Order No. 53, s. 2003 on the
