 - c. serve as DepEd institutional link to volunteer organizations and individuals;



- d. provide close horizontal and vertical coordination and consultation among DepEd, COMELEC, and partner agencies involved in the 2025 National and Local Election; and
- e. complement the other government agencies' efforts for an honest, orderly and peaceful elections.
- 5. All ETF Members shall be entitled to honoraria, subject to the availability of funds and in compliance with applicable issuances of the Commission on Audit and the Department of Budget and Management.
- 6. ETF members holding *plantilla* positions shall have the option to receive either honoraria or claim of overtime pay or compensatory time-off (CTO). An ETF member who opts to receive honoraria shall no longer be entitled to claim overtime pay or CTO.
- 7. Expenses that may be incurred during the election related activities shall be charged to Division MOOE subject to the usual accounting and auditing rules and regulations.
