a. To equip BKD Presidents for SY 2025 – 2026 with the knowledge and skills necessary to lead anti-drug campaigns in their respective schools and communities.


#### **Enabling Objectives:**







#### **ELECTION GUIDELINES**

#### I. Purpose

These guidelines aim to ensure a fair, transparent, and organized conduct of Division Federation of Barkada Kontra Bisyo (BKB) elections. This document outlines the eligibility criteria, election procedures, positions open for candidacy, conduct protocols, and post-election requirements.

#### II. Eligible Participants

Only the **duly elected/appointed Division Federation Presidents** from each Secondary Schools are authorized to participate, vote and run for a position in the Division Federation of BKB elections. Each participant will represent the learner organization from which they were elected.

#### III. Organization Covered

The following Division Learner Federation will conduct face to face election: a. Division Federation of Barkada Kontra Bisyo (DFBKB, Secondary)

#### IV. Positions Open for Election

The following positions will be voted during the elections:

- (1) President
- (1) Vice-President
- (1) Secretary
- (1) Treasurer
- (1) Auditor
- (1) Public Information Officer
- (1) Protocol Officer

#### V. Candidacy Requirements

#### 1. Election Application Form (EAF):

All interested candidates must **submit a duly accomplished EAF**. This form shall include personal information, current position, division represented, and the position(s) applied for (as provided).

#### 2. Number of Applications

A learner may apply for a maximum of seven (7) positions, corresponding to all the elective positions, but can only hold one elected position upon winning.

EAFs must be submitted **on the day of the Elections** to the designated Division Election Committee/Technical Working Group upon registration.

#### VI. Election Proper

#### 1. Candidate Presentations

All candidates shall be given equal time (maximum of 2 minutes) to **present their platform and advocacies** at the start of the election.

#### 2. Voting Process

Voting shall be done through **secret balloting**, supervised by the Division Election Committee as assigned. Ballots will be provided and collected in an orderly manner.

If all voters are candidates for the same electoral position, they are not allowed to vote for themselves.

Rationale: This restriction is necessary to prevent a situation where every candidate casts a vote for themselves, which could result in a tie and hinder the determination of a clear winner.

If not all voters are candidates for a specific position, then candidates may vote for themselves.

#### 3. Tie-Breaking Rule

In case of a tie, the decision will be made by a **coin toss**, witnessed and recorded by the election committee and participating voters.

#### 4. Campaign Restrictions

Strictly **no campaigning shall be allowed during the election proper**. Campaign activities must conclude prior to the scheduled election day.

#### 5. Prohibited Items

No campaign paraphernalia, printed materials, or any unrelated items shall be brought **during the election proceedings.** 

#### VII. Post-Election Activities

#### 1. Oathtaking Ceremony

Newly elected officers shall take their oath of office immediately after the elections. The ceremony will be led by a designated official from the Division Office.

#### 2. Assumption of Duties

All elected officers shall formally assume their respective duties and responsibilities upon conclusion of the oathtaking rites.
