MONITORING AND ROLL-OUT IMPLEMENTATION OF THE LEARNER RIGHTS AND PROTECTION (LRP) ON WHEELS AND BULLYING PREVENTION CARAVAN: DEVELOPMENT OF KINDNESS AND EMPATHY

1. In accordance with Regional Memorandum Nos. 0620 and 0662, series 2025, this Division shall actively monitor and support the implementation of the Learner Rights and Protection (LRP) on Wheels and Bullying Prevention Caravan themed "Development of Kindness and Empathy" in August 2025.

2. This advocacy seeks to reinforce child protection mechanisms and promote value-based interventions across schools.

3. All public and private schools are encouraged to display advocacy banners at school entrances or other prominent areas using the official designs available at:

4. Conduct classroom-based orientations utilizing interactive formats such as panel discussions, art-based activities, roleplays and simulations. These sessions shall cover the following topics:

- How to spot "Red Flags" of bullying
- Anti-OSAEC and Anti-CSAEM: Safer Internet Practices for Learners
- Empowering Learners to Report Learner Rights and Protection Abuse Cases to the Learners Helpline and Other Division Support Services

5. Socorro National High School (SoNHS) is the designated recipient school for this round of implementation.

6. Following a motorcade with invited Socorro Local Traffic Enforcers, Municipal Police Station and Municipal Social Welfare and Development Office personnel on August 19, 2025, there will be learner dialogue sessions, parents discussion, and distribution of LRP materials via the provided RO link, as well as immediate support and referrals for learners requiring assistance with SoNHS key stakeholders.

7. Designated Regional and Division deployed LRP Teams will oversee and facilitate all related activities to ensure effective implementation.

8. Additionally, SoNHS is required to submit a Completion Report to the LRP Office of SDO Siargao detailing the implementation and outcomes of LRP on Wheels activities.
9. Expenses incurred in the conduct of LRP on Wheels 2025 in SoNHS shall be charged against the Cash Advance made by Socorro National High School under the Program Support Fund for LRP.
10. Travel expenses of the Division LRP Team (Div. LRP Coordinator, 2 Div. LRP Alternates) shall be charged against a separate Program Support Fund allocation while travelling expenses of the participating SDO Siargao Personnel shall be charged against Division MOOE.
11. Immediate dissemination of this memorandum and strict compliance from all are concerned parties are hereby required.
