# DIVISION VALIDATION ON THE IDENTIFIED SCHOOLS FOR HEALTHY LEARNING INSTITUTION (HLI) CERTIFICATION

- In support of Republic Act No. 11223 or the Universal Health Care Act and aligned with the Department of Health's Health Promotion Framework, the Department of Education through the SGOD-SHNU continues to promote the Healthy Learning Institution (HLI) initiative. This program aims to create school environments that foster physical, mental, and social well-being among learners and personnel.
- A Healthy Learning Institution (HLI) is a school that promotes learner wellbeing by implementing health-promoting policies and practices based on a sixpillar framework. Initiated by the Philippines' Department of Education (DepEd) and Department of Health (DOH) in partnership with several other government agencies, the HLI program aims to create safer, healthier, and more inclusive learning environments, particularly for underserved communities. The program utilizes a whole-of-government and whole-of-society approach to address various aspects of school health, from physical and mental health services to community engagement and a healthy school culture
