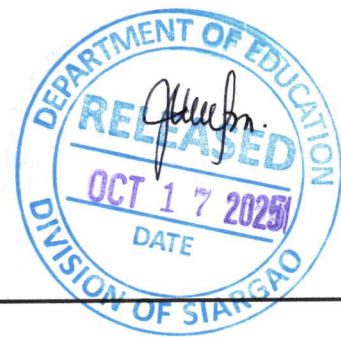

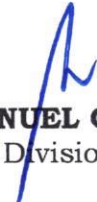
2. Participants are directed to submit, through this link: <https://bit.ly/learncon2025>, not later than October 18, 2025, the following documents, to wit:
