Orientation on the Implementation of CVIF-Dynamic Learning Program (CVIF-DLP) for Alternative Delivery Mode (ADM)

- 1. In view of the continuing disruptions to traditional classroom instruction caused by emergencies such as natural calamities, public health crises, and other unforeseen events, this memorandum serves to formally announce the implementation of **Alternative Delivery Modes (ADMs)** and the **CVIF-Dynamic Learning Program (CVIF-DLP)** as part of our institution's emergency education response.
- 2. These initiatives are intended to ensure the continuity of learning and uphold the quality of education during periods when face-to-face instruction is not feasible.
- 3. To facilitate the effective implementation of these programs, the necessary orientation and training will be scheduled on October 28-29 ,2025 at Division Training Center.
- 4. The participants include selected district ADM Focal persons and three (3) identified teachers per district, who are expected to cascade the training to all teaching personnel in their respective areas.
- 5. The objectives of this orientation are the following:
- a. To implement Alternative Delivery Modes (ADMs) and the CVIF-Dynamic Learning Program (CVIF-DLP) as part of the institution's emergency education response;
- b. To ensure the continuity of learning during emergencies that disrupt traditional classroom instruction; and
- c. To maintain the quality of education when face-to-face instruction is not feasible due to natural calamities, public health crises, or other unforeseen events.
- 6. Identified participants are requested to bring laptops and soft copy of a Revised K to 10 curriculum guides.
