

**CONDUCT OF FIVE-DAY DIVISION-BASED TRAINING FOR
MULTIGRADE TEACHERS**

1. In support with the Department of Education's continuous efforts to provide equitable and quality basic education in last mile multigrade schools, the Schools Division of Siargao shall conduct a **Five-Day Division-Based Training for Multigrade Teachers**. This training was originally scheduled last September 22-26, 2025, but was deferred due to the delayed conduct of the National Orientation on the Utilization of Multigrade Teaching and Learning Resources (October 28-30, 2025) and the Regional Cascading (November 13-17, 2025). Accordingly, the Division-based training is now scheduled on **November 26-30, 2025 at Almont Beach Resort, Surigao City**.

2. This training aims to equip educators with the competencies necessary for effective multigrade instruction. It will focus on differentiated instructional strategies, contextualized teaching approaches, and inclusive classroom practices to ensure that teachers can address the diverse learning needs of their students and foster a dynamic, learner-centered environment.

3. The participants of this training are select Multigrade teachers handling Grade 2&3 and 3&4 from all districts in the Division, with the following breakdown:
