

CONDUCT OF DIVISION-INITIATED MIDDLE READING ASSESSMENT
FOR IDENTIFIED LEARNERS IN GRADES 1 TO 12

1. In support of the Department of Education's thrust to improve literacy and reading proficiency among learners, the Division shall conduct a **Middle Reading Assessment** for learners previously assessed during the **Division-Initiated Reading Assessment**.
2. This initiative aims to monitor progress and strengthen intervention programs in Grades 1 to 12, specifically to:
 - a. determine learners' reading progress after initial interventions;
 - b. identify those requiring intensified remediation; and
 - c. provide data for planning targeted reading ARAL program sessions.
3. This will cover all learners assessed during the Division-Initiated Block Out Reading Assessment last July 2025 who fall under the categories: **Needs Immediate Intervention, Needs Enhancement Activities** and **Frustration Level**. Please refer to the table below:


5. The Middle Reading Assessment shall be conducted from **December 1-5, 2025**. Please refer to the table below for the assessors and the grade level to assess.

6. Submission of consolidated results to the Division Office will be on or before **December 5, 2025**. All schools are required to do the following:

- Use the official reading assessment tools provided by the Division Reading Focal Persons by Key Stage.
- Document results using the prescribed template.
- Submit both hard and soft copies of reports to the Curriculum Implementation Section through the Reading Focal per Key Stage.
