- ii. Photocopy of the Performance Rating obtained from the relevant work experience, if Performance rating in item (i) is not relevant to the position to be filled, if applicable.

4. For teaching position please enclose all pertinent documents in a green expandable folder and, for non-teaching positions, please enclose all pertinent documents in a red expandable folder. The deadline for submission is on or before **December 22, 2025** thru the Records section.

5. Interview and practical exam will be announced later. All qualified applicants will be notified thru call or text from HRMPSB secretariat for the details.

6. Late and incomplete submission of required documents will not be accepted and considered disqualified.
