**CALL FOR RESEARCH PROPOSALS FOR CALENDAR YEAR 2026**

1. In support of the policy development process, research agenda, and policy and program development and implementation of Department of Education (DepEd), this office, through the Planning and Research Section (PRS) and the Schools Division Research Committee (SDRC), hereby calls for the submission of basic and action research proposals for Calendar Year 2026.

2. This directive is anchored on DepEd Order 039, s. 2016, titled "*Adoption of the Basic Education Research Agenda*" and DepEd Order 16, s. 2017, titled "*Research Management Guidelines*", which institutionalizes research as a vital mechanism in improving the quality, relevance, and responsiveness of basic education programs and services.

3. For CY 2026, the division shall adopt the research agenda themes stipulated in the said policy, namely:

- a. Teaching and Learning
- b. Child Protection
- c. Human Resource Development
- d. Governance

Cutting across the four (4) major research themes are the following concerns, which must be integrated where applicable in all proposed studies. These are *Disaster Risk Reduction and Management (DRRM)*, *Gender and Development (GAD)*, and *Inclusive Education*.

4. Further, all research proposals shall be aligned with and anchored on the current 5-point priority agenda of the Department, as follows:

- a. High-Performing Teachers
- b. Improved Learning Environment that Safeguards Students' Physical and Mental Well-being
- c. Enhanced Governance Structures to Ensure an Efficient and Supportive Education System

- d. Improved Education Quality through an Upgraded Curriculum, Modernized Assessment, and Digitally-Enabled Schools
- e. Empowered Graduates Fit for Employment, Entrepreneurship, or Higher Education

5. To facilitate swift and systematic evaluation of research proposals, the following timeline shall be observed:

6. All proposals shall have a maximum of three (3) research proponents as stipulated in DO 16, s. 2017. The research proposals shall contain a maximum of 2,000 words and should abide with the provisions in the Research Management Guidelines. For research proposal inclusions of documentary requirements, the proponents shall comply with and accomplish the attached Annexes (**Annexes 1-3**).

7. Every district is required to submit two (2) research proposals (basic and

action research). All district supervisors are directed to ensure and facilitate the submission of the required number of the research proposals from their respective districts.

8. Teachers, school heads, and other personnel are also encouraged to develop and submit research proposals that respond to identified gaps, challenges, and emerging needs at the school, district, and division levels, and that can meaningfully contribute to policy enhancement and improved education outcomes.


9. The Schools Division Research Committee (SDRC) shall prepare for the evaluation of the anticipated submission of the research proposals in adherence to the process in the RMG. An official advisory shall be released separately for the schedule for the proposal hearing and research evaluation.

10. The research proponents and the SDRC members shall prepare and bring an accomplished Locator Slip duly approved by their immediate heads during their schedules. All participating research proponents shall be on *Official Business*.

11. Travelling Expenses and meal allowance/per diem of the participants shall be charged against local funds/MOOE subject to usual accounting rules and regulations.

12. All concerns relative to this directive shall be directed to Mr. Reiner S. Oraliza, SEPS/Division Research Coordinator.

13. For immediate dissemination to, guidance, and strict compliance of all concerned.
