**2026 SAFER INTERNET DAY PHILIPPINES AND CONDUCT OF THE CLASSROOM-BASED SESSION AGAINST ONLINE SEXUAL ABUSE & EXPLOITATION OF CHILDREN (OSAEC) AND CHILD SEXUAL ABUSE & EXPLOITATION MATERIAL (CSAEM)**

1. In reference to the Regional Memorandum No. 0137, s. 2026, on the Safer Internet Day (SID) Philippines and the conduct of Classroom-based on Online Sexual Abuse or Exploitation of Children (OSAEC) and Child Sexual Abuse or Exploitation (CSAEM), all schools are directed to facilitate the Classroom-based Session anytime within February 2026, pursuant to Presidential Proclamation No. 417.
2. The initiative aims to raise awareness on digital safety, strengthen the capacity of school personnel and parents to identify risks related to OSAEC/CSAEM and cyberbullying, and promote a positive digital environment grounded in kindness and respect.
3. The schools shall identify learners who participated in the classroom-based sessions and supervise them in producing a 10-30 second landscape-format video responding to the question: "How to promote kindness in the school community online and offline?"
