**ESTABLISHMENT OF LEARNER RIGHTS AND PROTECTION (LRP) DESKS
IN EVERY BILLETING QUARTER TO BE USED DURING THE DIVISION
IN-HOUSE TRAINING OF ATHLETES FOR CRAG 2026**

1. In adherence to the Department of Education's directives on learner safety and welfare, specially DepEd Order No. 30, s. 2012 DepEd Child Protection Policy, DepEd Order No. 55, s. 2013 (Implementing Rules and Regulations of RA 10627 – Anti-Bullying Act of 2013), and all related issuances, this Office hereby mandates the establishment of a Learner Rights and Protection (LRP) Desk in every billeting quarter during the Division In-House Training in preparation for the Caraga Regional Athletic Games 2026.
2. The LRP Desk aims to:
 - a. Provide a dedicated mechanism for reporting and addressing learner safety and welfare concerns;
 - b. Safeguard the rights of all learner-athletes and ensure that no learner-athlete shall be bullied, harassed, or discriminated against in any form duration of the training, and
 - c. Uphold gender-responsive and child-friendly standards in all billeting quarters
3. The School Child Protection Committee of the assigned billeting schools shall coordinate closely with the Division Learner Rights and Protection Team in DM No. 01-018, s. 2026 to ensure the continuous operation of a functional, confidential, and readily accessible desk on a 24/7 basis throughout the billeting period.
4. Billeting quarters must post clear and visible LRP Desk signages and display a list of School Child Protection Committee Members with contact numbers.
