**ORIENTATION AND ADMINISTRATION OF THE 2025 ACCREDITATION AND
EQUIVALENCY (A&E) TEST**

1. In reference to DepEd Memorandum OULS-2026-2-079 dated February 18, 2026, re: titled **“Rescheduling of the Administration of the 2025 Accreditation and Equivalency (A&E) Test.”**, the field is hereby informed of the conduct of the Accreditation and Equivalency (A&E) Test on March 29, 2026 at Dapa Central Elementary School and SPED Center, Socorro Central Elementary School and Bureau of Jail Management and Penology – Siargao.
2. Pursuant to **DepEd Order 55, s. 2016**, the A&E test aims to measure the competencies and life skills of those who have not attended or finished formal elementary or secondary education. This assessment shall allow the learners to obtain certification of completion at different exits in Basic Education, which may be used **to access further education, job promotion, entry to job training, and employment.**
3. Only the registered applicants with complete requirements shall be allowed to take the A&E Test at the testing centers approved by BEA. **No walk-in A&E Test takers shall be accommodated.**
4. **Virtual Orientation of all testing personnel** on the **standardized test** administration will be on March 25, 2026. Only those who attended the orientation shall be allowed to serve as testing personnel.
5. Only testing personnel and test monitors approved by DepEd officials specified in the A&E Handbook are allowed in the testing center premises during the examination day. **A&E Handbook** shall be provided after the national orientation on the administration of A&E Test.
6. The A&E test covers **seven (7) Learning Strands**. For Elementary, there are **135 items** and for Junior High School, there are **200 items**. **No photocopying or reproduction in any format** of Test Booklets and Answer Sheets.
7. Examinees should only bring pencils, erasers, and blank sheet of paper for computation. They may bring their valid IDs for identification purposes. Examinees

are **NOT** allowed to use digital devices and calculators during the test. Examinees should raise their hands if the test materials they received are defective. Examinees are provided with a **15-minute snack break**. No lunch break.

8. Examinees who are classified as Learners with Disabilities (LWDs), will be assisted by the **Assistant Examiner (AE)**. AE shall sign an **Oath of Confidentiality** prepared by the Division or Testing Center. Test Accommodations for Learners with Disabilities are stipulated in **Section 9** of DepEd Order No. 55, s. 2016.

9. The SDS is required to conduct an investigation on breach of security should there be any **irregularities** in the test registration and administration. The report on the investigation must be submitted to the **DepEd Regional Office** and BEA.

10. All expenses incurred for the A & E administration including test materials (*such as but not limited to pencil, paper, paste, and bond paper*), board, and lodging of the field-testing personnel is chargeable to NASBE Program Support Fund SARO-13-25-01354 and ALS Fund while the traveling expenses of the learner-takers and school personnel as chaperon from learning center to testing center are chargeable to PTA or school MOOE. All expenses relative to the A & E activity are subject to the usual accounting and auditing rules and regulations.

11. Testing personnel shall be granted Service Credit / Compensatory Time-off (CTO) for the services rendered during the weekend.

13. Immediate dissemination of this Memorandum is desired.
