**DIVISION SCREENING AND ACCREDITATION OF ATHLETES, COACHES,
ASSISTANT COACHES AND CHAPERONES FOR THE
CONDUCT OF DIVISION ATHLETIC MEET 2026**

1. Pursuant to Section 13 of Republic Act No. 10588 known as "An Act Institutionalizing the conduct of the Palarong Pambansa and Appropriating Funds therefor" and Section 17 (a) of DepEd Order no. 43 s. 2016 "known as the Implementing Rules and Regulations (IRR) of Republic Act no. 10588, The board shall constitute the National Screening and Accreditation Committee and shall likewise create the Regional Director the Regional Screening and Accreditation Committee (RSAC) and the Schools Division Superintendent create the Division Screening and Accreditation Committee (DSAC);

2. Thus, the Division Screening and Accreditation Committee shall conduct the screening of documents of athletes, coaches, assistant coaches, and chaperones on August 25-28, 2026 from the eighth (8) delegations such as:

3. The duties and functions of the Division Screening Committee (DSAC) – The DSAC shall:

- a) evaluate and verify the authenticity of the documents of athletes, coaches, assistant coaches, and chaperones submitted by the Head of Delegation for the Division Meet;
- b) accredit qualified athletes, coaches, assistant coaches, and chaperones and submit the master list to the RSAC, as the case may be;

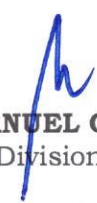
