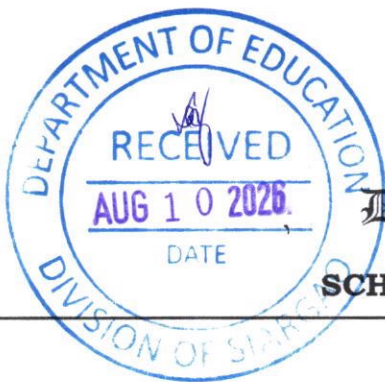
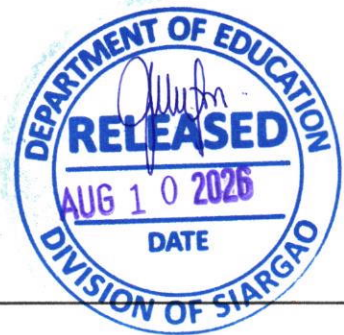

**ESTABLISHMENT OF LEARNER RIGHTS AND PROTECTION (LRP) DESK DURING
SCHOOL INTRAMURALS, SCHOOL PRESS CONFERENCES, ATHLETES'
BILLETING, TRAINING ACTIVITIES, FOR THE DIVISION ATHLETIC
MEET (SDAM) AND DIVISION SCHOOL PRESS CONFERENCE
(DSPC) 2026**

1. Pursuant to DepEd Order No. 40, s. 2012 (Child Protection Policy), Republic Act No. 10627 (Anti-Bullying Act of 2013), and other Learner Rights and Protection (LRP) policies, all schools conducting intramurals, & school press conferences and all venues of the School Division Athletic Meet (SDAM) and Division School Press Conference 2026 shall establish a highly visible LRP Desk in strategic and accessible locations, with appropriate signages and information materials on learner protection, reporting channels, and emergency contacts.
2. This Memorandum aims to:
 - a. Ensure the protection of learner participating in sports and athletic activities;
 - b. Establish accessible reporting and response mechanisms for learner rights and protection concerns; and
 - c. Provide immediate and appropriate intervention for cases involving bullying and other learner protection issues.
3. The School Child Protection Committee (CPC) shall designate and schedule its members to manage and supervise the operations of the LRP Desk throughout the duration of the activities.

4. The assigned school CPC members shall:
 - a. Received and document learner complaints, reports and concerns;
 - b. Provide immediate assistance and initial response to reported incidents;
 - c. Ensure confidentiality and protection of involved learners; and
 - d. Coordinate with appropriate school authorities for further action.
5. All cases involving bullying, harassment, discrimination, abuse, violence, or any learner rights and protection concern shall be immediately referred to the School Learner Formation Officer (LFO) for appropriate assessment, documentation, intervention and or referral.
6. The School Guidance Office/Guidance Designate shall be available at all times during the conduct of the activities to provide timely instruction, psychosocial support, and necessary interventions for learners affected by bullying and other learner protection concerns.
7. Participation of learners and personnel shall be subject to existing DepEd policies on off-campus activities, parental consent and safety protocols.
8. School Head shall ensure strict compliance with this Memorandum and shall closely monitor the implementation of the LRP Desk and related learner protection mechanism throughout the duration of the activities.
9. This Memorandum shall take effect immediately and shall remain in force throughout the conduct of the School Intramurals, athletes' training activities, athletes' billeting arrangements for the Schools Division Athletic Meet and Division Schools Press Conference 2026.
