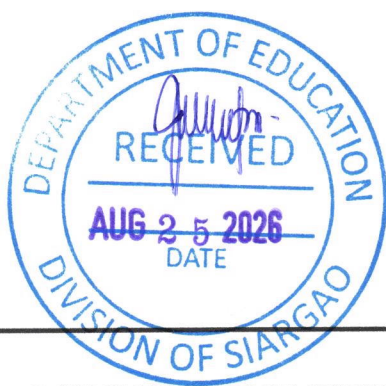

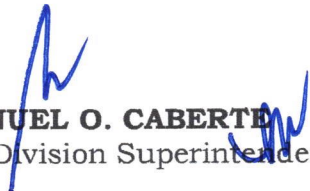
leadership by providing meaningful opportunities for volunteerism, active citizenship and an inclusive, safe school culture across the region.
