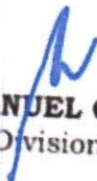
**ONLINE COORDINATION MEETING WITH EPP/TLE TEACHERS ON THE
FORTHCOMING DIVISION FESTIVAL OF TALENTS (DFOT) 2026**

1. In preparation for the forthcoming Division Festival of Talents (DFOT), this Office shall conduct an online coordination meeting with all EPP/TLE teachers on September 11, 2026 (Friday), at 1:30 in the afternoon via this link: <https://sdosiargao.com/MeetingEPPTLE2026DFOT>.
2. The meeting aims to discuss the contest mechanics, activity requirements, participant preparation, materials and equipment, task assignments, timelines, safety considerations, and other implementation arrangements for the following EPP/TLE-related DFOT activities:

 - Bake Cares
 - Cabin Craft
 - Savor D' Flavor
3. All EPP/TLE teachers are expected to participate actively and prepare relevant questions, share CIGPs during the previous conduct of DFOT for those who have participated, and propose materials and recommendations concerning their assigned or preferred contest activity. Teachers handling the identified events may also present electronic copies of existing guidelines or sample outputs for reference during the discussion.
4. School Heads shall ensure the attendance of the concerned teachers and provide the necessary administrative and technical support. Participants are advised to join the meeting at least ten (10) minutes before the scheduled time and use their official names and school affiliations upon entry.
