1. In support of the implementation of language mapping in basic education, this Office shall conduct an Online Orientation on Language Mapping and the Utilization of the Language Identification Tool (LIT) for Kindergarten to Grade 3 Learners in Private Schools of this division on September 11, 2026, at 8:00 in the morning via this meeting link: <https://sdosiargao.com/LITPrivateKto3TeachersSH>.
2. The activity aims to explain the language mapping process; demonstrate the proper administration and use of the Language Identification Tool (LIT); guide schools in recording, validating, consolidating, and submitting learner language data; and promote the appropriate use of the results in instructional planning.
3. Participants shall include private school administrators or school heads and Kindergarten to Grade 3 teachers and shall register through this link: <https://sdosiargao.com/LMOrientationPrivateSchools>. They shall have a stable internet connection, a functional device, and an electronic or printed copy of the LIT and related materials that can be downloaded or viewed through this link
4. Participants are advised to join at least ten (10) minutes early and observe proper online meeting etiquette.
5. All learner information collected through language mapping and the LIT shall be handled only for legitimate educational purposes and in accordance with applicable data privacy and records management.
6. No registration fee shall be collected.
